**Subject: Extension of the Period of Accreditation granted to Management program offered by Fore School of Management, B-18, Qutub Institutional Area, New Delhi-110016.**

Sir,

This has reference to NBA's letters of even number dated 18-05-2017, 11-11-2019 and 11-10-2020 under which Management programs offered by your Institution were granted accreditation for (3+1) years by National Board of Accreditation.

2. The National Board of Accreditation (NBA) has decided that in all cases of Management programs which were accredited for a period of (3+1) years upto 30-06-2021 in which the Institutions concerned have not been able to apply afresh for accreditation of the programs or if applied, the accreditation process could not be completed due to the current situation arising out of the pandemic caused by the Corona virus, the programs would be considered for accreditation of one year after expiry of the validity of accreditation on 30-06-2021 on the basis of the programs meeting the pre-qualifiers. The data submitted by **Fore School of Management, B-18, Qutub Institutional Area, New Delhi-110016** in the Pre-qualifiers has been examined and verified in NBA. Based on the same, the Competent Authority in NBA has approved the following accreditation status to the program as given in the Table below:

The application may be submitted online on e-NBA portal by 31<sup>st</sup> December, 2021.

6. The accreditation status of the above programs is subject to change on periodic review, as deemed necessary by the NBA. It is desired that the relevant information in respect of accredited program(s) as indicated in the Table in paragraph 2, appears on the website and information bulletin of your College/Institution.

7. The accreditation status awarded to the programs as indicated in Table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
