**Subject: Extension of the Period of Accreditation Status granted to Management programs offered by Fore School of Management, B-18, Qutub Institutional Area, New Delhi-110016**

Sir,

This has reference to NBA's letter of even number dated 18-05-2017 under which Post Graduate Diploma in Management and Post Graduate Diploma in Management (International Business) programs offered by your Institution were granted provisional accreditation for 2 years upto 30-06-2019 by National Board of Accreditation.

2. National Board of Accreditation (NBA) has decided that in all cases where Management program(s) of an Institution were granted provisional accreditation for a period of 2 years, the period of provisional accreditation of the program(s) shall be extended from 2 to 3 years subject to the condition that they meet the Pre-qualifiers. The Pre-qualifiers submitted by **Fore School of Management, B-18, Qutub Institutional Area, New Delhi-110016** have been considered in NBA. The following Management programs meets all the parameters of pre-qualifiers.
