Disclosure of the information

Internal:

We will not use your financial information for any other purpose other than to complete a transaction with you.

External:

We do not rent, sell or share your personal information and will not disclose any of your personally identifiable information to third parties unless:

- 2. Required to complete your transaction
- 3. To help investigate, prevent or take action regarding unlawful and illegal activities, suspected fraud, potential threat to the safety or security of any person, violations of terms of use or to defend against legal claims
- 4. Special circumstances such as compliance with subpoenas, court orders, requests/order, notices from legal authorities or law enforcement agencies requiring such disclosure

Opting out the services

Upon request, we will block/ remove your personally identifiable information from our database. However, the information will remain stored in archive on our servers.
