The Booksellers, Vendors, or Book stores interested in supplying books to the Fore School of Management (FSM) Library during the financial year commencing from 1st April 2020 to 31st March, 2021 are requested to apply for registration of their firm with FSM.

Sealed quotations/tenders are invited for the financial year of 2020-2021 from the reputed book suppliers based on the publisher to offer the highest rate of discount to the library on the supply of books as per the FSM Library terms and conditions.

The quotation is invited in two following categories separately:

- A) For supply of up to 5 copies of any title for Indian & Foreign Publications.
- B) For supply of more than 5 copies of any title for Indian & Foreign Publications.
- 1. Prescribed Performa to quote the rate of discount is available at the end of this document.
- 2. Please submit your quotations within the stipulated time; the quotations will be opened in front of Library Committee (LC) members in the next LC meeting.
- 3. In the case of Proprietary Documents / Items, the concerned firm/aggregator may communicate with us to appear for negotiation in the LC meeting.
- 4. Once the rate of discount offered by the book supplier is accepted by the FSM, the supplier cannot back out, and he has to submit an undertaking regarding the supply of library documents as per the library terms & conditions.
- 5. The rates of discount with other terms & conditions will be applicable for one financial year. It may be extended further with the mutual agreement if required.
- 6. In case any discrepancy is noticed at any stage; (intentionally or unintentionally by the supplier), the LC reserves the right to reject their quotations or blacklist their names.
- 7. The quotes received after due date and time or incomplete shall be rejected outrightly.
- 8. The FSM does not bind itself to accept the highest quotation and reserves the right to reject any or all quotations without assigning any reason thereof. The FSM reserve the right to accept or reject the quote in part or entirely.
- 9. The book supplier shall not decrease the rates of discount for any reason whatsoever during the agreement period. However, in any genuine case, it may be considered by the authority.
- 10. The book supplier should have at least five years' experience in the field. A list of reputed organizations where the bidder had given such service should be attached.

- 11. A certificate that your firm has not been debarred/blacklisted for any reason/period by any Central/State Govt. Dept./Institute/Organisation, etc. If so, particulars of the same may be furnished. Concealment of facts shall not only lead to cancellation of the order for the supply of books but may also warrant legal action/ debar/blacklist which deemed fit.
- 12. The book supplier shall deliver the books/documents to FSM Library premises at his expenses. The Library shall pay no freight for to and fro transportation. If freight for to and fro transportation etc. is applicable, it should be communicated in writing in advance.
- 13. The book supplier shall deliver all ordered books in one lot within the time limit specified in the supply order. The supply order can be extended by the Librarian only in exceptional cases on written request giving reasons/explaining circumstances due to which delivery period could not be adhered to.
- 14. The book supplier has to supply the new books in good condition and shall be responsible for a misprint, defected piece from the publisher, and any damaged books due to any reasons during transportation, etc. If any book/s found damaged, the recovery for the same will be adjusted from outstanding payment / pending bills of the book supplier.
- 15. The book supplier has to submit the bill along with the supply of books, or within 15 days of supply. On delay of any payment, no claim of interest or any charge will be entertained by the library.
- 16. The Appeal against any terms & conditions shall, however, lie with the Director, FSM whose decision shall be final. The dispute, if any, shall be subject to the jurisdiction of Courts at New Delhi. Any other jurisdiction mentioned in the quotations or invoices of the book supplier shall be invalid and shall have no legal sanctity.
