a. Bidder Technical Eligibility:

- Compliance to Specifications of Ruckus Wireless Solution: A duly signed and stamped compliance sheet on OEM letter head confirming that the offered solution meets all the technical specifications, features, and performance requirements outlined for the Ruckus Wireless Solution.
- **Certificate or Authorization Letter from OEM:** A valid certificate or letter issued by the OEM authorizing the bidder/firm to sell, supply, and provide support for the OEM's products within the specified region or territory.

- **Test Report Yes / No:** The bidder must submit a valid Test Report, certified by the OEM, verifying that the product meets the required performance and quality standards after delivery and installation.
- Certificate of Incorporation/ Firm Registration Certificate/ Article of Memorandum of Association/ Partnership Deed/ Proprietorship Deed: Relevant legal document establishing the existence and type of the bidding entity, depending on the nature of the organization—Private Limited Company, Partnership Firm, Proprietorship, etc.
